The reports from the GenAI Steering Committee meetings of 7 November and 29 November 2024 were circulated prior to this meeting and were noted by Academic Council.

# 6. Research, Innovation and Impact Strategy

Draft "SETU Connection Research to Impact 2024-2028" was circulated prior to this meeting. Prof. Van Hout advised members that the draft document is for discussion and has previously been presented to the Executive Management Team and Governing Body. A postgraduate webinar is scheduled for Friday, 13 December 2024 and members suggested, if possible at this stage, that post doctoral researchers be invited to the webinar. The final version of the document including a detailed operational plan is to be presented to Governing Body in Q1 2025 and, following final approval, the strategy will be launched.

#### 7. Work Plan for Academic Council Process 2024/5

Draft work plan for Academic Council for 2024/25 academic year was circulated prior to this meeting. Additions/amendments received since the previous meeting of Academic Council have been incorporated into the work plan.

**AGREED:** The following amendments/additions to the Work Plan for Academic Council Process 2024/25 were approved by Academic Council.

- Draft Academic Delivery Framework to be presented to Academic Council in March 2025 with the final version to be presented at the April 2025 meeting of Academic Council.
- Update on Faculty quality reports to be presented at April 2025 meeting of Academic Council
- TrustEd application draft application to be presented at January 2025 meeting of Academic Council with final application to be presented at March 2025 meeting of Academic Council.

#### 8. Update on IT Issues

D. Denieffe provided an update on the current status following the recent cyber security incident. Members raised a number of concerns which included student access to internet and printing facilities; the unsatisfactory move of certain classes to online delivery; timeframes for restoring the network access to the Walton building and the frustrations of the student body.

In relation to exams, members were reminded that Programme Boards have the authority to modify delivery and assessment, where appropriate, and the VP Academic, Teaching & Learning undertook to discuss any issues with the SU President. He also advised members that he is due to meet with the Administration Team to discuss the processing of examination results and that Registry and IT teams are currently working on this.

Concern was also expressed over the ability to register incoming students in January as this is currently being done manually with associated resource implications. Members acknowledged the work of Ms. Anne-Marie Frampton and Ms. Aishling O'Toole in trying to find a solution to this. A cohort of students are due to commence a programme in the Department of Computing and Mathematics in January 2025 and as this programme is delivered fully online, it was agreed the possibility of initially registering these students through the Carlow campus should be explored.

D. Denieffe advised that efforts are continuing to improve Wi-Fi services and acknowledged that some staff are still experiencing connectivity and speed issues. Wi-Fi services will be extended to College Street, the West Campus, the Granary, and the Applied Technology Building, as quickly as possible.

**NOTED:** A further update to all staff is due later this week.

**AGREED:** Report on Semester 1 examination results – year-on- year comparison to be presented to a future meeting of Academic Council.

#### 9. Teaching, Learning and Assessment Strategy Working Group

Document "Draft Proposal for the establishment of an SETU Teaching, Learning and Assessment Strategy Working Group" was circulated prior to this meeting and was noted by Academic Council. The Working Group will produce a Teaching, Learning and Assessment Strategy for SETU and, together with the associated implementation plan, will be presented to Academic Council for approval. The Strategy will align with the University's mission, vision, values and overall strategy as set out in *Connecting for Impact 2023-28*, and will aim to enhance the quality of teaching, learning and assessment within SETU.

Dr. Chris O'Riordan joined the meeting and gave a brief presentation on the proposal for the establishment of an SETU Teaching, Learning and Assessment Strategy Working Group which included introduction, objectives and process, structures, membership and timelines.

#### 10. Academic Unit Review – Department of Nursing

Dr. D. O'Byrne advised members that Academic Unit Review had been considered by the Joint Quality Committee at its meeting earlier today. Plans for the Department of Nursing & Health Care Academic Unit Review are in train with an expected completion date of the end of this academic year. It was agreed that a multi-year schedule of reviews and a guidance/procedure document for such reviews would be developed.
