Delegation Resolution

The Governing Body, in exercise of the functions conferred on it by Section 9(6) of the Technological Universities Act 2018 and by paragraph 1 of Schedule 2 to the Technological Universities Act 2018 hereby resolves to delegate to the President all of the functions of the Technological University associated with the appointment of staff including the approval of all new appointments with the exception of the following:

- 1. The functions relating to the appointment and removal and the setting of the terms and conditions of employment of the President provided for in Section 13 of the Technological Universities Act 2018.
- 2. The approval of the appointment of any staff member of SETU on a salary scale with a maximum that is equivalent to the maximum of the following scales:

Registrar, Secretary Financial Controller¹ or Head of Development Senior Lecturer III (Head of School) ²

In so delegating, the Governing Body notes that the President, in performing his or her functions, namely the functions hereby delegated and the other statutory functions of the President continues to be subject to such policies as may be determined from time to time by the Governing Body and shall be accountable to the Governing Body for the efficient and effective management of the Technological University and for the due performance of all of those functions.

The functions hereby delegated to the President are delegated on the basis that the Governing Body consents to the delegation by the President in writing of those functions to the various members of the senior management team, as appropriate, of the University reporting to the but noting that the President shall remain accountable to the Governing Body for the performance of functions so delegated by the President.
