### 1. Minutes of Academic Council Meeting of 19<sup>th</sup> September 2023

**NOTED:** Dr. Greg Doyle to be included in the apologies for the meeting of 19<sup>th</sup> September.

**AGREED:** The minutes of the Academic Council Meeting of 19<sup>th</sup> September 2023 were approved subject to the above minor amendment.

### 2. Matters Arising

**NOTED:** The Student Survey questionnaire to be circulated to all members.

**NOTED:** The Working Group on Academic Delivery Framework was not yet meet, a meeting will be scheduled in the coming weeks.

**NOTED:** There were no further comments on the Preliminary CAO data as presented at the Academic Council meeting of 19<sup>th</sup> September. A further more detailed report will be brought to the December meeting of Academic Council.

**3. Policies for Approval**

**NOTED:** There were no policies for approval.

**4. Committee Reports,****4.1 Research Committee**

**NOTED:** The Minutes of the Research Committee meeting of the 3<sup>rd</sup> October 2023 were circulated to all members prior to this meeting.

**AGREED:** As per the Committee Report the following were approved by Academic Council:

**NOTED:** Query was raised over the qualifications and supervisory record of two of the Supervisors proposed for Postgraduate Registrations. Dr. Tom O'Toole to follow up on this query.

**NOTED:** A presentation on the Structured Doctorate Evaluation by Prof. Grace Neville and document "*SETU Doctoral Programme Strategy and Operational Plan*" were circulated to all members prior to this meeting. D.O'Byrne and T. O'Toole gave a brief presentation on the report firstly acknowledging the 15 applications received and thanked all those who had worked on the applications. Members were advised that overall the report was very positive and took a collective approach to approval and to drive ambition in an evolutionary way. A summary of conditions for the approval of all 15 submissions as an integrated Doctoral Programme are as follows:

- The generation of a university-wide module catalogue that creates sufficient breadth and depth for doctoral candidates. Modules may be clustered thematically for the benefit of prospective students
- The generation of a register of approved supervisors, at university level, should be prioritised and this register should be a dynamic list with new supervisors added immediately on meeting the requirements to be a lead supervisor as laid out in the research regulations.
- That the University initially share QA infrastructure across a small number of large research boards (probably two is optimum) before eventually expanding into more discipline specific research bodies. This staged approach can reflect more focussed discipline development in line with evolving University growth and strategic achievement.

**NOTED:** T.O'Toole advised members that the goal is to have new University wide structure in place for January 2024.

**NOTED:** Members raised a number of concerns over the recommendations including over the status of the current Research Programme Boards and in particular the proposal to have only two research boards.

**AGREED:** The implementation plan, approved as part of the Graduate Studies Regulations at the November 2022 meeting of Academic Council, to be brought back to Academic Council for further discussion.

#### 4.2 Academic Development, Learning & Teaching Committee

**NOTED:** The Minutes of the Academic Development, Learning and Teaching Committee meeting of the 3<sup>rd</sup> October 2023 were noted by Academic Council.

**NOTED:** Work on the CINNETE Institutional Review has begun and the first meeting of the Institutional Review Steering Group was held recently.

**NOTED:** H. Farrell advised members that the AI Hub and AI Mate have attracted national interest and suggested the minute of the meeting should be more reflective of the work ongoing in the Hub.

**NOTED:** Document “*Student Guidelines on the use of Gen AI*” was circulated to all members prior to this meeting. Dr. H. Farrell spoke to the document advising members that infographics are being developed in tandem with this. A slide for display on all screens across campuses which includes a QR code (which brings the user to the guidelines) and a short video are also being developed with the aim of making this information as accessible as possible. Guidelines will also be circulated to all staff in all areas across all campuses and will be available on the AI Hub.

**AGREED:** The “*Student Guidelines on the use of Gen AI*” were adopted by Academic Council.
